Scope of Work:

- Whenever a snowfall accumulates to a depth of 2" or more the parking areas are to be plowed. Snow is to be removed down to the pavement and from curb to curb.
- Whenever a snowfall accumulated to a depth of 2" or more the sidewalks are to be plowed. Snow is to be removed down to the pavement and from curb to curb.
- Whenever a snowfall accumulated to a depth of .5" or more the sidewalks are to be shoveled. Snow is to be removed down to the pavement and from curb to curb
- De-icer is to be included in bid and provided by the contractor, and is to be applied to all cleared walkways and all parking areas.
