Project NOW, Inc. CAA, is seeking bids for the upcoming snow removal season for Rock Island, Henry & Mercer Counties. If you are interested in bidding for the snow removal in all or any counties, please **submit it no later than 5:00 PM on Wednesday, July 18, 2025**. Please place your bid in a SEALED envelope marked "Snow Removal Bids" to Project NOW, Inc. CAA at 1830 2nd Ave. Rock Island, IL 61201, Attn: **Properties. BIDS ARE TO BE DATE STAMPED AND RECIEVE A RECIEPT.**

Scope of Work:

- When snowfall accumulates to a depth of 4" or more the parking areas are to be plowed. Snow is to be removed down to the pavement and from curb to curb.
- When snowfall accumulates to a depth of 2" or more the sidewalks are to be shoveled. Snow is to be removed down to the pavement and from curb to curb.
- De-icer is to be included in bid and provided by the contractor and is to be applied to all cleared walkways and all parking areas.
- In the event of an Ice/ Sleet Storm, De-icer is to be applied to sidewalks and parking lots ASAP.
