Scope of Work:

- When snowfall accumulates to a depth of 2" or more, parking areas are to be cleared down to pavement, curb to curb.
- When snowfall accumulated to a depth of .5" or more, sidewalks are to be cleared down to pavement, curb to curb
- De-icer is to be provided & included in bid amount. De-icer is to be applied to all cleared walkways & parking areas.
- In the event of an Ice/Sleet Storm De-icer is to be applied to sidewalks and parking lots ASAP.
