Scope of Work:

- When snowfall accumulates to a depth of 4" of more the parking areas are to be plowed. Snow is to be removed down to the
 pavement and from curb to curb.
- When snowfall accumulates to a depth of 2" or more the sidewalks are to be shoveled. Snow is to be removed down to the pavement and from curb to curb.
- De-icer is to be included in bid and provided by the contractor and is to be applied to all cleared walkways and all parking areas
- In the event of an Ice/ Sleet Storm, De-icer is to be applied to sidewalks and parking lots ASAP.
