SUMMARY: Responsible for initiating, assessing, monitoring, and acting on work orders for Housing Rehab, Weatherization, Property & Assets, and inspecting all completed work.

ESSENTIAL DUTIES AND RESPONSIBILITIES: Include the following, other duties may be assigned.

- Record & review results of all assessments & work performed; use automated approaches to develop work orders according to guidelines. Completes all reporting and monitoring requirements.
- Performs duties relating to Housing, Weatherization, Properties & Assets, and Rehab projects including inspection, assessment, work spec development & construction cost estimates, bid prep & contract award.
- Assist with the selection of contractor(s), and the assignment of all work activities related to a job in accordance with all rules, contracts, policies and guidelines.
- Completes assessments and/or final interior/exterior inspections in Housing, Weatherization, Property & Assets, Rehabilitation projects, and other programs as required.
- Responds to customer questions/concerns related to work to be performed or that has been completed.
- Evaluate & address safety needs of home as they relate to fire risk, CO2 poisoning, lead hazard reduction in relation to single-family rehab projects, including inspections, assessments, & monitoring of lead safe work practices by contractors. Inspect & evaluate residential units for compliance w/HQS & lead paint regs.
- Perform work as requested for multiple departments and participate in required meetings and trainings.
- Performs field inspections to ensure steady progress on projects.
- Monitors workmanship, quality, & project completion.
- Identify substandard conditions in residential construction and recommend correction in compliance with local codes and Housing Quality Standards.

- Ability to effectively use and conduct field tests with tools & equipment; trouble shoot as necessary.
- Must have strong organizational skills; be able to multi-task and work independently to meet program goals.
